NOTICE

Subject: Withdrawal/Cancellation of Advertisement Notice No. 06 of 2023 dated 21.12.2023 for recruitment to teaching positions in the University of Ladakh.

Whereas, the Advertisement Notice No. 06 of 2023 dated 21.12.2023 was issued by the University of Ladakh for recruitment to various teaching positions on the basis of the roster/reservation position applicable at that time;

Whereas, the process pursuant to the aforesaid advertisement progressed only up to scrutiny/shortlisting of applications and, owing to administrative exigencies and other unavoidable circumstances, could not be carried forward to the interview stage;

Whereas, no interviews have been held, no Selection Committee has made any recommendation, no select list has been approved and no appointment order has been issued pursuant to the aforesaid advertisement;

Whereas, the present Vice-Chancellor assumed charge on 01.02.2025 and, after reviewing the pending recruitment file, initiated steps for screening/processing of applications; however, the substantial lapse of time and material changes in the reservation framework/policy applicable in the Union Territory of Ladakh necessitated a comprehensive examination of the matter;

Whereas, the prolonged gap between the date of advertisement and the proposed completion of the process may exclude candidates who acquired the prescribed qualifications during the intervening period and may create uncertainty and legal complications;

Whereas, the Hon'ble Chancellor, after considering the aforesaid circumstances and relevant records, has approved withdrawal/cancellation of the aforesaid advertisement and initiation of a fresh recruitment process in accordance with the prevailing reservation policy, applicable UGC norms and University rules, in the interest of fairness, transparency, equal opportunity and legal sustainability;

Now, therefore, with the approval of the Hon'ble Chancellor, Advertisement Notice No. 06 of 2023 dated 21.12.2023 is hereby withdrawn/cancelled with immediate effect.

Consequential directions:

1. No applicant shall have any claim for interview, selection or appointment merely by reason of submission of an application, scrutiny/shortlisting or any other step taken under Advertisement Notice No. 06 of 2023.
2. This order does not cast any stigma or adverse implication upon any applicant and shall not affect the right of any eligible person to apply afresh in response to a fresh advertisement, subject to fulfilment of the eligibility conditions prescribed therein. Candidates who paid the prescribed application fee in response to the said advertisement shall not be required to pay the fee again, subject to submission of satisfactory proof of such payment.
3. The University shall issue a fresh advertisement after finalisation of the subject-wise requirement and category-wise roster, in accordance with the prevailing reservation policy, applicable UGC norms and University rules. Applications shall be invited from all Indian nationals; however, preference shall be given to candidates belonging to the Union Territory of Ladakh in accordance with the new reservation policy of the UT of Ladakh. Where no suitable candidate is available in a particular subject against the relevant reserved category, a candidate may be selected on an open basis and the reservation shall be carried forward in accordance with the applicable policy.
4. The concerned section/officials shall take necessary action for publication of this order and for processing the fresh recruitment proposal expeditiously.
